



## **Koppers Awarded Export Order for Railroad Ties**

### **Total Estimated Value of Order Approximately \$20 Million**

PITTSBURGH, PA, Apr 11, 2008 (MARKET WIRE via COMTEX News Network) -- Koppers Inc., a subsidiary of Koppers Holdings Inc. (NYSE: KOP), announced today that it will be providing approximately 360,000 railroad crossties for new tracks being installed for mining operations in West Africa. The company began shipping the material at the end of March. The total order, which also includes switch ties and bridge lumber, has a value of approximately \$20 million.
